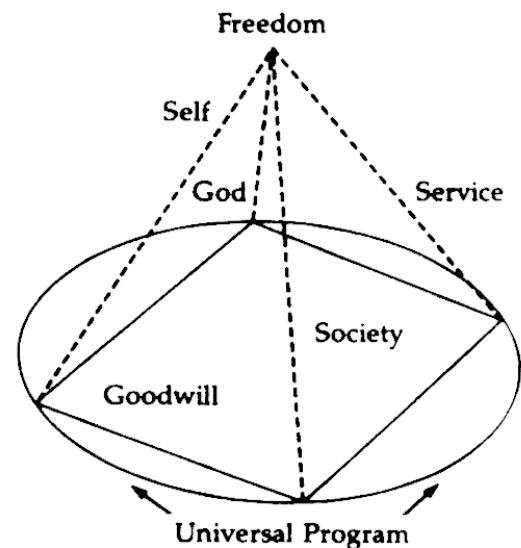
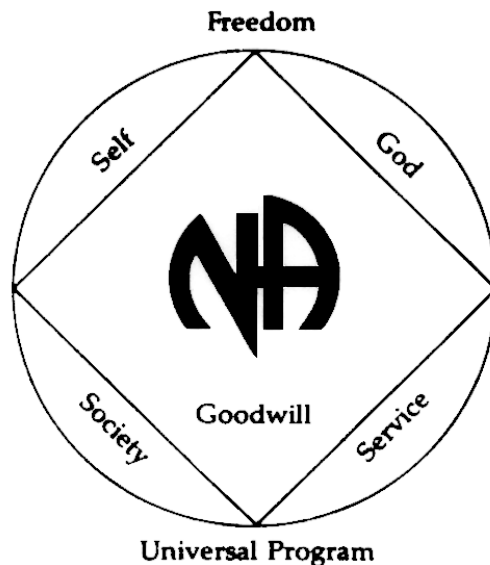

POINT OF INFORMATION: A point of information is a question directed to the Chairperson to obtain information concerning parliamentary procedure on the motion that is pending. This allows a member to ask a question and **it is not to make a statement or give information.**

Finally, at the beginning of area when the chairperson asks a committee member to give a trusted servants presentation:

Following the first roll call at each ASC, a trusted servant of the area (Admin Member, Committee Chair, or GSR) will share a short presentation of their service position including their role within the body they serve, the responsibility of their position, and any other pertinent information that may be helpful to those members new to the service structure.

It is very important that we follow the trusted servants presentation so people understand what other positions entail, and determine whether or not they may be interested in such a presentation. This is not a forum to explain why you do service for NA, but rather give information to new members about your position and give a little more information about the area and regional service structure. This is especially important to our area because we have such a lack of volunteers to do service.
