

South Broward Area ASC Minutes

James opened the meeting at 12:00 pm with the Serenity Prayer,

Daniel S. read the Twelve Traditions. Roberta read ASC Definition.

<u>Liz S.</u> - I have been a member of the South Broward area for 5 years and I have been doing service at the area level for 4 years. I have so much love for this area and I feel the need to share how I'm feeling. After the last area in October I was very concerned about how our area is doing. I brought my concerns to region last month and spoke to a few people on how they thought best to handle it. They recommended that I get up here in open forum and bring it up. I feel that many people who are holding positions in our area have been very rude and disrespectful. It is a privilege to hold a position in Narcotics Anonymous, it does not mean you are any better than anyone else. It simply means that you have an opportunity to lead by example on how we do things here.

The last time we met, it was very dysfunctional to say the least. I remained quiet in the back and watched. It was a screaming match between personalities, rather than a discussion between mature adults practicing the principals of this program. While, this by itself can be concerning, that is nothing new at area and that is not what troubled me the most. What troubled me the most, was that when new GSRs raised their hand to ask questions they were shut down and made to feel as though questions weren't welcome here. I can't imagine where I would be in my life or in my recovery if I hadn't been allowed to ask questions about things I didn't understand. I certainly would not be doing service and I may not even still be clean. How are any of these people supposed to relay the correct information, or learn how to do things properly if they can't ask questions? In the future the blame will only be on us for not teaching these people how to appropriately fill their positions.

One of the most important things we can be in recovery is teachable. If you think you know it all and remain closed minded, how can you absorb any new information or learn a better way of doing something? Personally, the way things are going here is not an area I want to be a part of. There are a few areas that are really struggling for service and participation right now and ours is one of them. If we continue on the path we are on, it will only get worse. How can we expect new people to get involved and fill positions? If last month were the first area I ever attended, I don't know if I would be back. Remember, this is about attraction rather than promotion and the way things are going, it's not very attractive. We need to use our experience as a teaching tool and show each other the right way to do things. Ego has no place here, we work together, not in competition with each other. We need to understand the importance of what we're doing. We're keeping this going for the people coming in behind us. We are going to be someone's predecessor someday, don't we want to do right by them? Can our area turn over a new leaf and become a great area that people want to be a part of? My

husband suggested that I remind everyone of our 6th concept, "Group conscience is the spiritual means by which we invite a loving God to influence our decisions."

One is a money motion for travel expenses for people attending the RSCs, the second one is a policy change that is a result of what happened with the SFRCNA convention and we need to vote on the budgets for the sub-committees.

We did not present the motion for the regional PR sub-committee to match the funds brought in by the PM Pancakes for PR fundraiser. The committee voted on submitting a new line item to their budget to cover this cost as well as future costs for other areas to do the same.

The RD has started working more closely with the Florida Region and they are working on creating a coordinated calendar that includes events for both regions. Also we will be holding a workshop for any interested GSRs or members who would like to understand the information in the CAR report better this will be held Saturday December 12. We will have fliers for that made up before Brittany sends out the minutes so she can send a flyer out with the minutes, we are still working on the location for that event. Robert will be getting a head count from GSRs who want a CAR report for their home groups.

We also had our first report given at this last region by the representative of the new position that was created last year, the additional needs Point of Contact. She will be creating a guideline for groups on what to do when faced with accessibility challenges.
