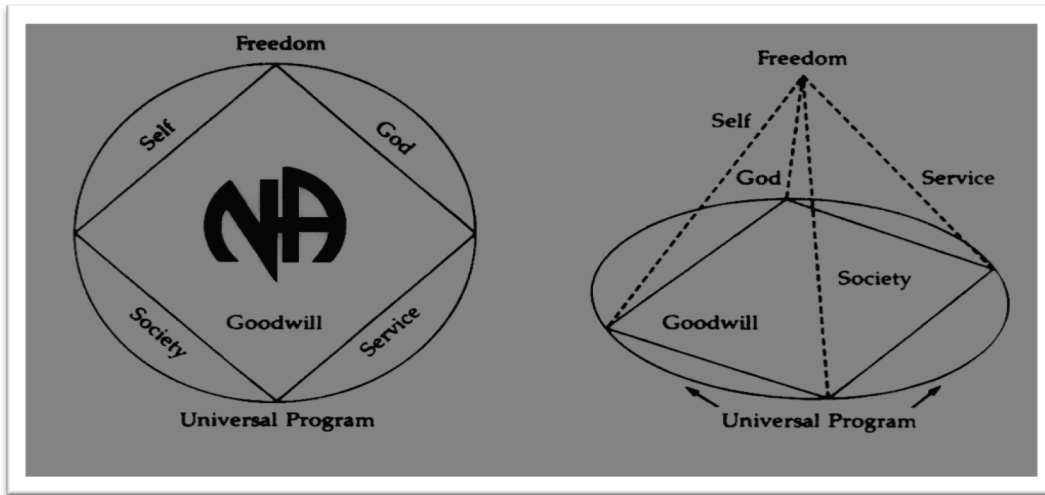

spreading in some pockets of NA.

Also, there are voices of disunity that would tear us apart concerning Narcotics Anonymous literature.

Sadly, some of these voices are in our own region. Although they are few they can be very loud.

South Florida region fully embraces our entire current library of recovery literature believing it's the best that's ever been written.

We appreciate and trust our trusted servants and recognize the exceptional job NAWS has done in supporting and growing this truly worldwide fellowship. Intent: A unity Statement Financial Impact: \$0

**Motion 04-07-18**

Motion reads: To expel Freedom Area from the SFR service as they do not use NA approved literature and there for do not carry a clear NA Message.

Maker: Beach and Bay 2nd: South Atlantic

Financial impact: \$0 Intent: To Maintain NA unity and preserve the integrity of our message. Send Back to groups: 4-9-0 Fail Motion tabled by maker Gold Coast makes motion to pull off the table. 2nd Beach and Bay. Passes unanimously. Beach and Bay makes a motion to send this motion to ASC. 2nd: So Dade 9-2-2 Passes Motion sent to ASC.

Con by RD: Our 12th Concept states that "In keeping with the spiritual nature of Narcotics Anonymous, our

structure should always be one of service, never of government." The Freedom Area doesn't use literature,

their groups do. Who is going to determine which meetings carry a clear NA message? Have we reached a

point where we want to have one set of members judge another set of members to determine whether they

belong in NA? Should one set of groups decide if another set of groups belong? Can we not see the danger in

having one set of people sitting as judge, jury and executioner of others? These are but some of the reasons

why our structure should never be of government. That's probably why no area has ever been kicked out of a

region...anywhere. Do we really want to be the first to have such a dubious distinction? There have got to be

spiritual solutions that don't rely on kicking groups and areas out of a region.

---

Pro- Beach & Bay-

This motion seeks to maintain the integrity and the unity of the South Florida Region and preserve the Narcotics Anonymous message for those who have not had a chance to experience it.

Several Regions ago, the Freedom Area asked to join the South Florida Region and made a proclamation in front of the entire regional body by an emphatic declaration that they supported the use of illicit literature and that the grey book and the baby blue were their primary sources of recovery literature used in their meetings. Their RCM report further stated that "their only concern at this time" was to promote the inspection of the Fellowship Intellectual Property Trust.

An agenda made clear and a direct challenge to the members of this region who seek to uphold the group conscience established by the fellowship in World Services Conferences from 1984 to 2008.

The grey form is a rough draft of the basic text fraught with mixed messages and inconsistent with the message Narcotics Anonymous has today. Reading it reminds me of when I first tried to write a fourth step-----misguided and

confused. The baby blue is an amalgamation of older versions of the basic text that had to be updated to better reflect the realities of service and recovery principles within the fellowship.

By using and reproducing this literature, the Freedom Area is not only violating copyright law but also our 1st Tradition which tells us that our recovery depends on the unity of our fellowship and, by extension our message; the Freedom Area is violating our 2nd Tradition by the blatant disregard of the group conscience from regions throughout the world when they voted on one piece of literature to signify one consistent message; the Freedom Area abuses the spiritual nature of our 4th Tradition when they ignore the fact that with autonomy comes responsibility; that by giving the newcomer an unbalanced and patchy message which contradicts the message of the fellowship as a whole, it is not only reckless and un-spiritual, but down-right dangerous. This certainly affects NA as a whole!

Some might argue that this motion is un-spiritual in nature; however, we submit that nothing can more spiritual than preserving our message, the most precious thing we have, for those who need it. We cannot allow anyone to mix and match and produce whatever they want and call it NA. In this we will not negotiate.

The Beach & Bay Area does not wish to kick anyone out of NA (we are members when we say we are) however we do not believe that it is in the interest of the area, the region, or NA in general to allow individuals to abuse the fellowship which saved our lives. And we do not endorse the participation of the Freedom Area in this region's service structure.

We will not support groups, areas, or regions emotionally, spiritually, nor will we do it financially, that promote the use of baby blues and the grey form in Narcotics Anonymous meetings.

We implore the other areas in this region to take a stand and protect the integrity of the words and principles our newcomers depend on every day, in every meeting, all over this region.

Con- East Central FI- When Freedom Area came to the South Florida Region they stated that the Florida region had remove them from their region and refused their meetings access to the BMLT. The SFR then voted unanimously to accept them knowing they used baby blues and grey books. Are we a member when we say we are or not?
